

ASOPE® TEXTBOOK USE AGREEMENT

Below are the terms and conditions of the textbook use agreement. By signing the user receipt, you agree to the terms and conditions.

The ASOPE® Textbook Use Program allows students to study for an ASOPE® license without going to a Special School or Outside Training.

Terms of Agreement

1. I am at least 18 years of age and a currently have filled out an ASOPE® application and have been approved for an ASOPE® test.
2. I am entering this Textbook Use Agreement ("Agreement") with the ASOPE® Textbook Use Program of my own free will.
3. I understand that the materials rented to me are the property of the ASOPE® Textbook Use Program.
4. I am responsible for the condition of the materials used. I bear the full responsibility for the return of the materials in salable condition and for payment of fees and new book replacement costs if materials are lost, stolen, or returned in unsalable condition. Unsalable condition includes damages incurred to the material as determined by the ASOPE® Textbook Use Program ASOPE National Office staff, including but not limited to torn covers, torn pages, or liquid damage. Limited highlighting and writing in the rented textbook are permitted.
5. I will return the materials to the ASOPE® Textbook Use Program on or before the return date. The ASOPE® Textbook Use Program is not responsible for reminding me of the return date and is not responsible for returns shipped to the office via any carrier.
6. If I fail to return the Materials by the return date, I understand that a hold will be placed on all ASOPE® Licenses until such time as I pay all financial debts to the ASOPE® Textbook Use Program.
7. Replacement of materials (exact duplicate, correct ISBN, title, author, edition, etc.) required; only new copies will be accepted as a replacement in lieu of any damaged user materials on or before the return date. Replacements will be accepted with the approval of the ASOPE® Textbook User Program ASOPE National Manager or Assistant Manager.
8. I have read and fully understand the provisions and the terms of this Agreement as outlined and I agree to adhere to all conditions and terms as stated.
